Steven Spielberg yacht cruises around Mallorca

Palma.—Hollywood legend Steven Spielberg's mega superyacht *Seven Seas I* is cruising in Mallorca. This week she was anchored off Puerto Portals. It is not clear if the *Jaws* director is on board.

The yacht is named in honour of his children. He sold the original *Seven Seas* about four years ago and then built a "bigger boat" in the form of *Seven Seas I*.

This is not the first time that the *Seven Seas I* has visited Mallorca. Spielberg sailed around Mallorca on board his yacht last summer alongside Daniel Day-Lewis.

The *Seven Seas I* was built in 2023 and cost around \$250 million and the family have sailed to Mallorca after a cruise off France.

TRUMP v. SPAIN

Madrid.—The European Commission and Spain's government this week dismissed U.S. President Donald Trump's latest threat to impose higher tariffs on Madrid over its refusal to meet his proposed NATO target for defence spending.

Trump said he was "very unhappy" with Spain for being the only country to reject the

new spending objective of five percent of economic output, adding that he was mulling over punishing the country. He had previously suggested making Spain "pay twice as much" in trade talks.

Trade policy falls under Brussels' remit and the Commission would "respond appropriately, as we always do, to any meas-

ures taken against one or more of our member states," Commission spokesperson Olof Gill said in a press briefing.

The trade deal between the European Union and the United States signed in July was the right platform to address any issues, Gill added.

"The defence spending debate is not about increasing spend-

ing for the sake of increasing it, but about responding to real threats," Spain's Economy and Trade Ministry said in a statement.

"We're doing our part to develop the necessary capabilities and contribute to the collective defence of our allies."

Spain has more than doubled nominal defence spending.
